

Penguins Fan's Request for a Kidney Goes Viral

Family House provided "home away from home" for her family while she recovered



It's what you need. It's a nice space to recover. By the time Kelly Sowatsky attended the Pittsburgh Penguins hockey game in March last year, she had been searching for a kidney donor for weeks. She figured it couldn't hurt to take her plea public, so she made a poster to bring to the game: "Calling all hockey fans! I need a kidney! Kidney! Kidney! Gratefully yours, Kelly." She thought maybe she'd get lucky and her poster would be featured on the jumbotron at the game.

Instead, Kelly's poster caught the eye of the Penguins marketing team, and its official Twitter account shared the image, which was then shared and liked thousands of times online. Hundreds of people from around the world reached out to Kelly asking how they could get tested, and eventually she found a match.

Kelly and her kidney donor travelled to Pittsburgh for the surgery, and their families were able to stay just minutes from the hospital at Family House. Having loved ones close by can improve patients' recovery, and the homelike atmosphere and supporting community at Family House enabled both families to relax after long, stressful days at the hospital.

"When my mom needed a break, she was able to come back here and just rest," Kelly said. "It's a quiet, very peaceful place to be. You're surrounded by other people going through similar situations with their families"

At Family House, Kelly's family enjoyed home-cooked meals prepared and served by community volunteers. Her family also would relax in the common areas of the house, reading books, playing games, or chatting with other guests. It became a "home away from home" for the two families, both of which had traveled hours to Pittsburgh.

"It becomes a family feel," Kelly said. "You might not know the person you're sitting next to, but you know that they're going through something similar, and everybody supports one another." A LETTER FROM THE EXECUTIVE DIRECTOR

Considering a gift to support Family House?

Did you know you may qualify to use earnings from your Individual Retirement Account (IRA) to make your gift? A "qualified charitable distribution" might be right for you. To learn more, Family House reached out to Board Chair Al Vallano, a financial advisor with Hefren-Tillotson, who explained how a "QCD" works.

Family House Donor (FHD): Changes in the tax law have raised questions about "qualified charitable distributions." What exactly is a qualified charitable distribution and how could it help me continue to support Family House?

Al Vallano: Ordinarily, all deductible contributions to a traditional IRA, plus earnings, are subject to federal income tax when they are later distributed. However, if the IRA owner meets certain requirements, she or he may be able to transfer funds directly from the IRA to a qualified charity and, consequently, exclude the withdrawal from taxable income. This is called a qualified charitable distribution or QCD.

FHD: Can anyone use a QCD?

AI: QCDs are reserved for individuals who meet certain requirements. For example, the IRA owner must be at least 70.5 years old on the actual date of the distribution. Also, the maximum distribution amount is \$100,000 per year, per taxpayer, and married couples can utilize \$200,000 (\$100,000 per spouse) worth of QCDs each year.

FHD: Could I direct a QCD to Family House?

AI: Absolutely! In fact, the distribution must go to a public charity—like Family House—and it must be one that would otherwise be eligible for a full charitable deduction. And the check must be made payable to the charity, not to the IRA owner.

FHD: What else should I know about QCDs?

Al: A QCD cannot be made to a private foundation or donor-advised fund. In addition, a charitable remainder trust or charitable lead trust cannot be the recipient of a QCD. Finally, it is important to know that the donor must not receive any benefit(s) from the charity in return for her/his donation.

FHD: How can I find out if a QCD is a good fit for me?

AI: Questions about gifting a QCD to Family House and which types of IRA are eligible can be answered by a qualified financial advisor. And if you want to know what the impact of your gift of a QCD would be on Family House, contact Beth at BBrown@familyhouse.org.

"I give through my IRA; it's the easiest way for me to donate, and I even benefitted tax-wise from it. I am thankful that I am able to contribute my small part to this wonderful organization."
